Board Conference Room April 13, 2021 Board of Commissioners Minutes

The regular meeting of the Oceana County Board of Commissioners was called to order by Chairperson Walker in the Board Room of the Oceana County Courthouse on Thursday, April 13, 2021, at 11:40 a.m. via Zoom.

Roll was called by the Clerk. Present: Mr. Hardy, Ms. Meyette, Mr. Morse, Mr. Erickson, Mr. Christians, and Mr. Walker. Mr. Beggs attended via Zoom.

Dr. Sobie, Oceana County Administrator, and Ms. Amy L. Anderson, Oceana County Clerk, were also present.

Moved by Mr. Morse and seconded by Mr. Christians to approve the minutes from the March 25, 2021 meeting as presented.

Moved by Mr. Hardy and seconded by Ms. Meyette to approve the closed session minutes of the Special Closed session meeting of March 31, 2021.

Voice vote, Motion carried.

Public participation was provided via audio/videoconference using Zoom. The online meeting ID was 829 8481 5914.

Mr. Walker asked if any commissioners wished to declare a conflict of interest on the agenda items. No conflict of interest was declared.

No public comment at this time.

RESOLUTION NO. 1 - APPROVING THE 2021 EQUALIZATION REPORT

Moved by Mr. Hardy and seconded by Mr. Christians to approve the 2021 Oceana County Equalized Valuation of \$1,847,926,940 with an equalized value of real property of \$1,780,444,040 and equalized value of personal property of \$67,482,900 as shown by the 2021 Analysis for Equalization in compliance with Section 211.34 M.C.L. 1948, as amended.

Furthermore, the County Clerk and Chairperson of the Board are authorized to sign the "L-4024 as Assessed and Equalized Valuations Report" for the political subdivisions of the County and the State Tax Commission. The 2021 County Equalization Value reflects a 2.61% increase in Equalized Value and a 2.80% increase in Taxable Value overall when compared to the 2020 values.

RESOLUTION NO. 2 - REAPPOINTING A MEMBER TO THE OCEANA COUNTY JURY BOARD

Moved by Ms. Meyette and seconded by Mr. Hardy to reappoint Ms. Janice Foster to the Oceana County Jury Board effective May 1, 2021 for a six year term expiring April 30, 2027. The reappointment is made upon the recommendation of the 27th Judicial Chief Circuit Judge Robert Springstead and is pursuant to Public Act 454 of 2000.

RESOLUTION NO. 3 - APPROVING A PAID SICK LEAVE ASSISTANCE POLICY FOR EMPLOYEES

Moved by Mr. Christians and seconded by Ms. Meyette to accept the Oceana County Administrator's recommendation to approve a COVID-19 Paid Sick Leave Assistance Policy as presented. The purpose of the policy is to provide paid sick leave assistance to qualifying county employees during the continuing pandemic outbreak of COVID-19. The policy shall be effective retroactive to March 1, 2021 through December 31, 2021, unless otherwise extended by the Oceana County Board of Commissioners.

RESOLUTION NO. 4 – ESTABLISHING A NEW FUND FOR RECORDING FINANCIAL ACTIVITY STEMMING FROM A FUNDING ALLOCATION FROM THE AMERICAN RESCUE PLAN ACT

Moved by Mr. Hardy and seconded by Mr. Christians to authorize the County Administrator to establish a new fund, American Rescue Plan Fund, for recording financial activity occurring from a funding allocation derived from the American Rescue Plan Act of 2021. Establishing the fund will allow for a more efficient means of accounting and reporting the use of the funds to the U.S. Department of Treasury. A fund number will be assigned once the Michigan Department of Treasury offers guidance on the appropriate fund number to use.

RESOLUTION NO. 8 - RECOGNITION OF NATIONAL CHILD ABUSE PREVENTION MONTH

Moved by Mr. Morse and seconded by Mr. Christians to adopt the following resolution on this 14th Day of April, 2021:

- **WHEREAS**, Child Abuse Prevention Month is acknowledged throughout the United States annually in April; and
- **WHEREAS**, Child Abuse Prevention Month provides an opportunity to raise awareness and educate the community on the various ways to support families and prevent abuse and neglect; and to recognize that child abuse and neglect is a complex and ongoing problem in our society; and
- **WHEREAS**, every child is entitled to be loved, cared for, nurtured, feel secure, and be free from verbal, sexual, emotional, and physical abuse, and neglect; and children are vital to our county's success, prosperity, and quality of life, and are our most valuable assets for the future; and
- **WHEREAS**, preventing child abuse and neglect is a community problem affecting the current and future quality of life of our community; and
- **WHEREAS**, child abuse and neglect can be prevented by making sure every family and caregiver have the support they need to raise their children in a healthy environment; and
- **WHEREAS**, the majority of child abuse and neglect cases originate from situations and conditions that are preventable; and with the help of an engaged and supportive community, child maltreatment can be eradicated by effective prevention strategies;
- **NOW THEREFORE, BE IT RESOLVED**; That the Oceana County Board of Commissioners hereby recognizes April as National Child Abuse Prevention Month in Oceana County and encourages citizens, community agencies, faith-based groups, to join in our local, state, and national efforts to prevent the maltreatment of children to further strengthen the communities in which we live.

Ms. Meyette spoke briefly about The Hope Project, an organization out of Muskegon County, that assists individuals that have been trafficked.

Mr. Erickson stated that he attended a very productive Parks & Recreation Commission meeting last week. He is very impressed with Mr. McKeen's leadership. He also attended a District Health Department #10 meeting, in Cadillac, which was an in-person.

Mr. Christians reported that he attended the Weare Township Board meeting. One topic of discussion was road improvements.

Mr. Morse informed the Board that fiber optic cables have begun to be installed in areas of the county.

Mr. Hardy mentioned that Starlink, a satellite internet constellation, is being constructed by SpaceX to provide satellite internet access. He also mentioned that Mason-Oceana 911 is ready to kick-off its CAD system soon.

Mr. Sobie noted that he received the names of the individuals that are interested in the vacancy on the Road Commission Board. They are: Joshua Draper, John Hendrixon, Dennis Koch, David Spitler, and Andrew Sebolt.

Mr. Walker stated that he attended an Economic Development meeting today where Mr. Richard Rafaelli commended the County of Oceana for the partnership with the Right Place.

Chairperson Walker asked if there was any further business to come before the Board. There being none, the meeting adjourned at 12:16 p.m.
