The regular meeting of the Oceana County Board of Commissioners was called to order by Chairperson Walker, in the Board Room of the County Building, on Thursday, October 14, 2021, at 11:47 a.m.

The Pledge of Allegiance to the Flag of the United States of America was led by Chairman Walker.

Roll was called by the County Clerk. Present: Mr. Hardy, Ms. Meyette, Mr. Beggs, Mr. Christians, Mr. Erickson, and Mr. Walker. Absent: Mr. Morse.

Also present: Dr. Sobie, Oceana County Administrator, Ms. Anderson, Oceana County Clerk; and Ms. Peggy Wittman, City of Hart resident.

### **Public Comment**

She has attended many meetings and is still unclear as to what their policies are trying to protect. There has been email correspondence from Gary Davis, OCMFC Administrator, asking for help

in stopping this. Since then the facility's protocol has changed and Ms. Wittman is concerned that OCMFC is not keeping Covid-19 out of the building.

### RESOLUTION NO. 1 - APPROVING AN AMENDMENT TO THE MDOT AGREEMENT FOR AIRPORT IMPROVEMENTS

Moved by Ms. Meyette and seconded by Mr. Erickson to approve the following resolution regarding an amendment to a contract for a Federal/State/Local Airport Project, Contract No. 2021-0684 between the Michigan Department of Transportation and Oceana County Board of Commissioners:

- **WHEREAS**, the Oceana County Board of Commissioners has the authority to contract with the Michigan Department of Transportation for State and/or Federal funds for airport related services; and
- **WHEREAS**, the Oceana County airport's current Airport Improvement Program identifies projects eligible for federal funding, such as runway, taxiway, and taxilane rehabilitation; and
- **WHEREAS**, the Michigan Department of Transportation is requesting that Contract No. 2021-0684, originally dated May 27, 2021, be amended to allow for a project in the category of Seal Runway Pavement Surfaces/Joints.
- **NOW THEREFORE BE IT RESOLVED**, that the Oceana County Board of Commissioners does hereby approve the requested amendment to Contract No. 2021-0684 and authorizes the County Administrator to sign all necessary documents.

# RESOLUTION NO. 4 – MAKING APPOINTMENTS TO THE OCEANA COUNTY BROWNFIELD REDEVELOPMENT AUTHORITY'S BOARD OF DIRECTORS

**WHEREAS**, on July 8, 2021, the Oceana County Board of Commissioners established the Oceana County Brownfield Redevelopment Authority ("the Brownfield Board"); and

**WHEREAS**, on September 23, 2021, the Oceana County Board of Commissioners appointed seven (7) of nine (9) members to Brownfield Board; and

**WHEREAS**, the Oceana County Administrator is recommending appointments for the remaining two (2) seats on the Brownfield Board for the terms of office stated below. The terms of office take effect October 1, 2021. All subsequent terms of office shall be for three (3) years:

- 1. Ms. Anne Pawli one (1) year term
- 2. Mr. Richard Huntington one (1) year term

**NOW THEREFORE BE IT RESOLVED**, the Oceana County Board of Commissioners approves the above described appointments to the Brownfield Board and directs the Oceana County Administrator to notify these individuals of their appointment and to coordinate their participation in an organizational meeting of the newly established Brownfield Board.

Discussion ensued regarding re-districting that recently took place, dropping Oceana County down to five districts. Concerns were voiced and more information will be provided to the Commissioners.

#### Commissioner's Reports

Ms. Meyette noted that Christian Health Centers will be leasing a space in Newaygo County and looking for other areas closer to Oceana County. She suggested that Dr. Sobie and our Economic Development team to look into the benefits of potentially bringing them to Oceana.

Mr. Christians thanked Oceana County and the Board for letting him be a representative at the Michigan Association of Commissioners (MAC) conference on Mackinac Island. He attended many great programs and found it to be very worthwhile.

Mr. Erickson found it alarming that the OCMFC will be losing approximately \$400,000 per month due to low census numbers, which is raising many concerns. They are also interviewing for a new director.

Dr. Sobie noted that the Strategic Planning Report had been distributed to the Commissioners. The next step will be to identify the action steps for the first set of goals. This could start as early as the next meeting on October 28<sup>th</sup>.

### **Public Comment**

Ms. Wittman continued her public speech regarding OCMCF and how the staff put her mother in law in an interior room so she could not have window visits. They asked if they could do Monoclonal Antibody treatment for her mother. Ms. Wittman declined to have the treatment done as her mother was not sick and had not been sick. Ms. Wittman also stated that the OCMCF has been letting college students in to do coursework, but still won't let her in to see her mother.
