FY 2022 Budget

The FY22 budget is coming to a close. I have been working through the budget to prepare for year end and it looks as though use of fund balance will be minimal to none as revenues came in higher than expected.

Transfer Station

A meeting is being scheduled with Ferry Township and American Waste. Information will be forthcoming.

Legislative Update

The Lame Duck sessions will begin on November 9th. MAC is unsure what they will attempt to complete in Lame Duck. They believe they will be meeting between 6 and 9 sessions days before they adjourn. MAC will continue to push for the following in Lame Duck:

- Creation of a revenue sharing trust fund and increase to county revenue sharing.
- Back filling losses associated with the disabled veteran's property tax exemption.
- Remote participation via the Open Meetings Act.
- Restoration to collect fees for criminal defendants to help fund courts.
- Blocking privatization of the mental health system.
- Appropriations of remaining ARP funds for infrastructure.
- Securing reimbursement for the expansion of the personal property tax exemption.

MAC remains hopeful that these items will be accomplished.

Health Insurance

Health Insurance documents are being finalized in preparation for open enrollment.

Public Comment

Mr. Morse invited Mr. Maynard, Oceana County Economic Alliance, to speak on a project that he has been working on to bring new jobs to Oceana County. He stated that Purdue Chicken will be coming to Shelby and will be located in the former Oceana Foods building. He also commented on the watermain extension project that involved a grant through MEDC.

There being no further business to discuss, Chairperson Hardy adjourned the Finance and Equalization Committee meeting at 11:17 a.m.

HEALTH & HUMAN SERVICES AND PARKS & RECREATION COMMITTEE MEETING

The Health & Human Services and Parks & Recreation Committee Meeting was called to order in the Board Conference Room at the Oceana County Building by Chairperson Erickson on Thursday, November 10, 2022, at 10:00 a.m.

Lee Hyslop, Crystal Township Supervisor; Mr. Garry McKeen, Oceana County Parks & Recreation Commission; Mr. Pat Ruggles, Crystal Township resident; Mr. John Warner, Oceana County Deputy Drain Commissioner; Mr. Ron Maynard, Crystal Township resident; and Mr. John Cavanagh, Oceana's Herald - Journal correspondent.

Moved by Mr. Christians and seconded by Mr. Walker to approve the minutes from the October 13, 2022 meeting as presented.

Voice Vote. Motion carried.

Chairperson Erickson asked if there were any changes to be made to the agenda.

Moved by Mr. Beggs and supported by Mr. Hardy to approve the agenda as presented.

Voice vote. Motion carried.

Public Comment

There was no public comment at this time.

Discussion ensued regarding the Crystal Valley Dam. Ms. Byard provided the Board with a report from on the options for the Crystal Valley Dam from the Spicer Group.

Mr. Walker encouraged the Board listen to all information prior to making any decision.

Mr. Hyslop, Crystal Township Supervisor, requested additional time to procure more information. He he has received several bids for this project and is expecting additional bids to be received. He has also discussed some options with De Wind Wells and De Watering. Mr. Hyslop also asked to be placed on the agenda for the December 15, 2022, meeting so that he can provide the information gathered.

Mr. Beggs raised concern with language in a deed that would allow property surrounding the dam to revert back to original owners/heirs.

Mr. Erickson shared a legal opinion that was obtained on this subject dated February 21, 2022, that addressed this issue.

Mr. Pat Ruggles, Crystal Township resident, offered a possible solution to repair the dam.

Mr. John Warner, Oceana County Deputy Drain Commissioner, advised that permit(s) from EGLE with engineered plans would be required.

Unofficial

Mr. Garry McKeen, Oceana County Parks & Recreation Commission, offered the names of several agencies that may be able to assist with issues at the Crystal Dam.

Ms. Byard began discussion regarding the Brownfield Redevelopment RFP. The Brownfield Redevelopment Board is requesting the acceptance of Envirologic Technologies, a consulting firm that assists the Brownfield Redevelopment Board, to assess various projects.

Ms. Byard recommended the reappointment of Mr. Jeff Hiddema to the Parks & Recreation Commission.

Mr. McKeen advocated for the re-appointment of Mr. Hiddema.

Public Comment

Mr. Hyslop asked if the Board had any questions that they would like addressed by the December 15th meeting that would be critical in their decision making. Mr. Morse stated that he would like to know how vested financially the people of the township would be.

Mr. McKeen, reported that on November 21, 2022, there will be a meeting at the County Services Building to discuss questions, concerns, and ideas regarding the benefits of a new recreation club in the county.

Mr. Walker noted that Mr. McKeen brought a request to the Administrator's office for reforestation regarding the area surrounding Marshville Dam.

Mr. McKeen expressed that there is a potential grant available through Conservation Resource Alliance (CRA) and would like a letter of support from the County Board of Commissioners. He also announced that he applied for a \$2,500 grant, from the Community Foundation of Oceana County, for two benches to be replaced at Gales' Pond.

There being no further business to discuss, Chairman Erickson adjourned the Health & Human Services and Parks & Recreation Committee meeting 11:07 a.m.
