- Chairman McKeen received a phone call from a concerned citizen regarding Crystal Valley Park. They stated that there was trash piling up and that the electrical outlets in the shelter were not working. Mr. McKeen brought this to Mr. Chandler's attention so he could address it.
- Chairman McKeen texted with Tammy Carey of the Oceana Community Foundation regarding the parks grant. The foundation gave \$3,000.00 for the purchase of tables and benches. Specifically, two ADA tables are to be used for Cedar Point Park.
- The EGLE permit was granted for the Marshville Dam/Stony Creek restoration project. The permit was signed and returned to EGLE for final signatures.

Chairperson's Report

- Chairman McKeen attended the Crystal Township meeting to make the board aware of the continued vandalism at the park. One of the citizens requested that the neighbors frequent the park more often to help with the ongoing vandalism issue.
- Check received from Great Lakes Energy Peoples Fund for \$1717.00 to purchase three ADA picnic tables that can be placed at any of the County Parks.
- Attended two ORC meetings, the Benona Township meeting and the MTA meeting in Elbridge Township.
 - MTA meeting at Elbridge Township discussed in detail the Shelby blight ordinance that has been adopted. A document with full details can be found on Shelby's website.

Parks Reports

• Black Lake – Mr. Spitler reported that about half of the seasonal campers have paid, and the rest will be paid sometime in July 2023. Mr. Spitler noted that one of the picnic tables needs to be replaced. The table will be replaced with one of the five that Mr. Mikkelsen has been storing. Alice reported that the second well test was done.

Motion made by Mr. Spitler to authorize the expenditure of \$550.66 to Alice Johnson for mileage reimbursement and hours for May 2023, supported by Mr. Mikkelsen.

- Cedar Point Park Mr. LundBorg reported that he met with Dave Fox; he will be doing some work out there in a few weeks. Mr. Mikkelsen will take a few of the steps that are to be removed from Cedar Point Park. Mr. LundBorg reported that attendance is picking up with the nice weather. He plans on getting the elevated walkway done, hoping to have that completed by June 18, 2023.
- Crystal Valley Park Mr. Chandler reported on the concerns with the trash and that a birthday party ended up overfilling the trash can. Mr. Chandler asked Howard's Lawn Care to start emptying the garbage at Crystal Valley Park. Mr. Chandler stated the electrical outlets at the pavilion are no longer working. He will contact Blackmer Electric to have them come out and see why they are not in working order. Mr. Hyslop created a new protection cage over the motion detector; however, the motion detector is broken and needs to be replaced. Mr. Chandler, Mr. Hyslop, and Mr. Erickson are all making rounds to Crystal Valley Park to help ward off the ongoing vandalism issue.

Motion made by Mr. Chandler to authorize the expenditure of \$20.00 per month to Howard's Lawn Care for trash service through October of 2023 at Crystal Valley Park, supported by Mr. Erickson.

- Gale's Pond Mr. Mikkelsen reported no further progress has been made at this time. The walkway is safe to walk on at this time. Blackmer Electric still needs to make it out to work on the East side.
- Mill Pond Mr. Hiddema reported he found a Ferry resident to do the mowing. Mr. Hiddema reported that the vandalism at Mill Pond has subsided.
- Marshville Dam nothing to report by Chairman McKeen.
- Stony Lake Mr. Mikkelsen reported that he was able to get the mowing done, and Memorial Day was a very busy weekend; the boat launch got a lot of use. Chairman McKeen reported that he was approached by Larry Porter, and his uncle Vinny Porter donated the park to the township in 1927. Larry Porter would like to see his uncle's name put back on the sign.

Old Business

Great Lakes Energy installed the light out at Crystal Valley Park.

- Pam Blough of PM Blough presented the Parks & Recreation Commission with the
 adjusted drawings, including not expanding the campground and utilizing the park for day
 use. Ms. Blough suggested focusing on the parking, pavilion, and signage to acknowledge
 the day-use option. Discussion ensued on the revised Black Lake Park Preliminary Master
 Plan, with a plan to welcome Pam Blough back on August 3, 2023, Parks & Recreation
 Meeting.
- Chairman McKeen and Mr. Mikkelsen will go out to Lutheran Brotherhood Bridge at Gales Pond and assess the damage to determine the amount needed to be spent to repair it.

Motion made by Mr. Mikkelsen to authorize the expenditure of \$750.00 to extend the Lutheran Brotherhood Bridge, supported by Mr. Erickson.

- Crystal Creek Dam Mr. Erickson spoke with J.E Tiffany and Sons, LLC regarding Crystal Valley Dam Engineering.
- ADA Parks Report Mr. Wilson would like an additional three hours approved for the Network Disability Network.

Motion made by Mr. Hiddema to authorize three additional hours at \$65.00 an hour to Network Disability Network, supported by Mr. Chandler.

- Chairman McKeen will be doing work with the local GRANGE group at Gale's Pond. He would like a motion to purchase wood chips for the pathways at Gale's Pond.

Motion made by Mr. Erickson to authorize the expenditure not to exceed \$200.00 for the purchase of wood chips at Gale's Pond, supported by Mr. Mikkelsen.

• Chairman McKeen discussed the current benches at Gale's Pond Boardwalk. He stated they are not in very good shape. He would like to replace them in the near future with three ADA park benches.

• Chairman McKeen discussed suspending the Parks & Recreation meeting in July 2023.

Motion made by Mr. Mikkelsen to suspend the July 6, 2023, Parks & Recreation meeting, supported by Mr. Hiddema.

Chairman McKeen discussed creating a program for people to adopt a County Park. This
program would hopefully get the community interested in volunteering to help clean up
our County Parks.
