

The Oceana County Planning Commission meeting was called to order by Chairperson Greiner on Thursday, August 3, 2023, at 1:00 pm, in the Oceana County Board of Commissioners Room, 100 S. State Street, Hart, Michigan.

PLEDGE OF ALLEGIANCE

APPROVAL OF THE MINUTES

Moved by Mr. Cutter and seconded by Mr. Blohm to approve the minutes of the July 6, 2023, with the correction of adding Mr. Blohm to being present for the meeting with Oceana County Planning Commission meeting. Voice vote. All ayes. Motion carried.

APPROVAL OF THE AGENDA ITEMS OF THE REGULAR MEETING

Moved by Mr. Stivers and seconded by Mr. McKeen to approve the August 3, 2023, agenda with the addition of Pentwater's consideration to become a city. Voice vote. All ayes. Motion carried.

PUBLIC COMMENTS ON AGENDA ITEMS

OLD BUSINESS

- Master Plan Update:
 - At the July 6, 2023, meeting, Stephen Carlson, master plan consultant from West Michigan Shoreline Regional Development Commission, planned to request from all the government entities within the county with Planning Commissions their future land use maps. As of this meeting, he was making those contacts.
 - At the July 26, 2023, Oceana Chapter of Michigan Township Association (MTA) meeting held at Ferry Township Hall, Commissioner Morse solicited township input for the county master plan. He also asked to be on their agenda for their next meeting.
- Training:
 - Commissioners discussed possible ongoing training opportunities.

NEW BUSINESS

- Farmland and Open Space Preservation Program: Chairman Greiner explained an email that was received from an official of MIDARD that an application from Elbridge Township previously reviewed by OCPC had been denied for failing to meet the minimum area requirement.
- Pentwater Village consideration to obtain city designation: Following general discussion, Mr. Morse agreed to contact John Amhrein, MSU Extension Service Specialist, on public policy to address the role of county planning commissions in this process.

CORRESPONDENCE

- Chairman Greiner acknowledged the receipt of a letter from the Zoning Administrators of Pentwater Township and Village of Pentwater in which they solicited comment on the draft of their combined master plan. There was limited discussion.

COMMISSIONERS REPORTS

- Mr. McKeen reported that the Oceana Conservation District's Hazardous Waste Collection is scheduled for Saturday, August 19, 2023, from 9 am to 1 pm at the Hart Department of Public Works, 1010 S State Street.
- Mr. McKeen reported Oceana County Parks and Recreation Commission is currently out for bids on the improvements at Stony Creek County Park and Marshville Dam Road. Eight contractors attended the July 28th site review. Bids are due on August 15, with work commencement scheduled for spring 2024. Red pines to be harvested from the park will be used in toe wood bank stabilization.
- Mr. Morse, who represents Ferry Township on Oceana County Board, indicates their planning and zoning boards may still need to fill positions.
- Mr. Morse reported that the County Commissioners have funded an engineering study of the dam adjacent to Crystal Valley County Park.

PUBLIC COMMENT


There was no public comment at this time.
