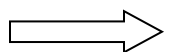

**PLAN REVIEW REQUIRED: PLANS MUST BE SUBMITTED BEFORE A PERMIT CAN BE ISSUED!!!**

Plans are required for all building types and shall be prepared by/under the direct supervision of an architect/engineer licensed pursuant to Act No. 299 of the Public Acts of 1980, as amended, and shall bear the architect's or engineer's signature/seal, except: 1. When the electrical rating is not over 400 amps and the bldg is not over 3,500 sq ft in area. 2. Work completed by a governmental subdivision or state agency costing less than \$15,000.00
