

Properties, Environment, and Economic Development Committee

The Properties, Environment, and Economic Development Committee Meeting was called to order by Chairperson Erickson, on Thursday, October 26, 2023, at 10:01 a.m. in the Board Conference Room.

Present: Mr. Morse, Mr. Hardy, Mr. Walker, and Mr. Erickson. Absent: Mr. Beggs.

Also Present: Ms. Byard, Oceana County Administrator, Mr. Garry McKeen, Oceana County Parks and Recreation Commission; Mr. John Cavanagh, Oceana's Herald-Journal correspondent; and Ms. Anderson, Oceana County Clerk.

Moved by Mr. Morse and seconded by Mr. Walker to approve the minutes of the September 28, 2023 Properties, Environment, and Economic Development Committee as presented.

Voice vote. Motion carried.

Chairperson Erickson asked if there were any changes to the agenda. Ms. Byard requested the addition of the Snow Plow Bids motion #2023-117.

Moved by Mr. Hardy and seconded by Mr. Morse to approve the agenda as amended.

Voice vote. Motion carried.

Public Comment

There were no public comments at this time.

Agenda Items

Mr. McKeen, Oceana County Parks and Recreation Commission (OCP&R), explained that various grants were applied for, however were denied. He stated that OCP&R is working on a Crystal Valley County Park master plan. He stated that and invoice from PM Blough and Assoc., was presented in the amount of \$4,350.00 for payment of the landscaping for the project. Crystal Township has agreed to cover \$2,175 (50%) and he believes that it would be beneficial for Oceana County to contribute and requested consideration to authorize funds in the amount of \$2,175 for the remaining portion of the invoice to facilitate the progress of the project. He indicated that this will be on the OCP&R agenda at the next meeting. Mr. Walker stated the board was aware of this project and feels the County Board should allow this expenditure.

Ms. Byard requested consideration for the reappointment of Mr. Bill Adams and Mr. Mike Blackmer to the Construction Code Board of Appeals through July 31, 2025.

Ms. Byard requested consideration to adopt Resolution #2023-11 opposing the pre-emption of local control in solar and wind siting and zoning. Mr. Morse noted that he conversed with Rep. Curtis VanderWall this morning and reported that the Statewide Septic Code and the pre-emption of local control in solar and wind siting and zoning have not been brought to the table yet, however, Sen. Bumstead and Rep. VanderWall have been working diligently on the opposition of both of these.

Ms. Byard indicated that there were two snow plowing bids received which are from the same Companies as the previous year. A bid from Hallack Contracting for locations one and two as well as Beckman Bros. for locations three and four was received. Ms. Anderson read the amounts listed on the bids.

Public Comment

Garry McKeen, Oceana County Parks and Recreation indicated the Gales Pond Project is completed. Cedar Point continues to be worked on.

Chairperson Erickson asked if there was any further business to come before the Board. There being none, the meeting adjourned at 10:18 a.m.

Agriculture Highlight



Oceana County boasts a diverse agricultural economy that produces over \$212 million annually, 60% in crop sales and 40% in livestock.

MSU Extension is helping to make a difference in Oceana County.

Highlights of MSU Extension Agricultural support in 2023: Oceana County has a long history of dependence on natural resources, and in particular agriculture, as a strong source of identity and economic prosperity. MSU Extension provided education and support to Oceana County residents through a variety of targeted workshops and services. In 2023,104 programs related to agriculture, agricultural business, and food systems were attended by residents of Oceana County

The presence of the West Michigan Research Station in Hart provides an opportunity to bring to Oceana County expertise in various disciplines. Spring Horticulture Day is an annual program offered for West Central Michigan tree fruit growers. Approximately 90 growers attended, heard from commodity experts, networked, and received 3 pesticide application and continuing education credits for certified crop advisors for this program. Asparagus Day is a similar event, drawing in growers from across the mid-west. In 2023, 139 participants took home essential knowledge to help them maintain best practices in crop management, disease prevention, storage techniques, and more, as well as having some industry vendors available for information.

The 2023 Farm Field Day was held on Aug 8 at the West Central Michigan Research and Extension Center and was co-organized by MSU and the local MAEAP technician, Lynda Herremans. This event was in partnership with the Oceana Conservation District, Farm Bureau, and the West Central Michigan Horticultural Research Center, with additional sponsorships from 14 industry partners. With over 90 attendees, this field day highlighted fundamentals of current spray equipment and technologies that growers can use to improve farm efficiency and fruit quality. Spray drones were demonstrated in asparagus and cherry trees, and an autonomous sprayer, the mini-GUSS, was demonstrated in pear trees.



<u>West Central Horticulture Breakfast Meetings</u> are seasonal meetings for tree fruit growers to share timely information, weather updates, and pest and disease information about ongoing or emerging issues. This is a great meeting to share information with growers and engage industry members who sponsor breakfast each week. Coupled with one-on-one farm visits and local research plots, Extension services remain an essential piece of a thriving agricultural economy.

Oceana County farmers took advantage of a webinar focused on creating a farm business plan. The business plan helps to evaluate alternatives, identify market opportunities, and communicate ideas to potential lenders and business partners. Participants explored how to understand what lenders look for in a business plan when farms are seeking loan financing.

Additionally, in the spring of 2023 MSU Extension relaunched soil testing services for both home and commercial purposes. Both segments took advantage of the testing and accompanying analysis that MSU Extension soil testing services produces.



Resolution #24-06

RESOLUTION TO ADOPT MASTER PLAN

WHEREAS, the Michigan Planning Enabling Act (MPEA) authorizes the Planning Commission to prepare a Master Plan for the use, development and preservation of all lands in the County; and

WHEREAS, the Planning Commission prepared a proposed updated Master Plan and submitted the plan to the County Board for review and comment; and

WHEREAS, on December 7, 2023, the Oceana County Board received and reviewed the proposed Master Plan prepared by the Planning Commission and authorized distribution of the Master Plan to the Notice Group entities identified in the MPEA; and

WHEREAS, notice was provided to the Notice Group entities as provided in the MPEA; and

WHEREAS, the Planning Commission held a public hearing on March 7, 2024 to consider public comment on the proposed updated Master Plan, and to further review and comment on the proposed updated Master Plan; and


WHEREAS, the County Board finds that the proposed updated Master Plan is (a) desirable, (b) provides factual information about Oceana County, and (c) promotes coordination of land use and development decisions within Oceana County;

WHEREAS, the MPEA authorizes the County Board to assert by resolution its right to approve or reject the proposed Master Plan;

THEREFORE BE IT HEREBY RESOLVED AS FOLLOWS:

- 1. **Adoption of 2024 Master Plan.** The County Board hereby approves and adopts the proposed 2024 Oceana County Master Plan, including all of the chapters, figures, maps and tables contained therein. Pursuant to MCL 125.3843 the County Board has asserted by resolution its right to approve or reject the proposed Master Plan and therefore the approval granted herein is the final step for adoption of the plan as provided in MCL 125.3843 and therefore the plan is effective as of March 28, 2024.
- 2. **Distribution to Notice Group.** The County Board approves distribution of the adopted plan to the Notice Group.
- 3. **Findings of Fact**. The County Board has made the foregoing determination based on a review of existing land uses in the County, a review of the existing Master Plan provisions and maps, input received from the Planning Commission and public hearing, and with the assistance of the West Michigan Shoreline Regional Development Commission, and finds that the updated Master Plan will support and facilitate coordination of the use, preservation, and development of lands in Oceana County.
 - 4. **Effective Date.** The Master Plan shall be effective as of the date of adoption of this resolution.

Sheriff Body Scanner- A request from the Sheriff's Office to approve the purchase of a Tek84 Intercept Full Body Scanner to prevent the introduction of illegal substances into jail. There has been a significant increase in attempts to smuggle deadly illicit drugs into the jail. This poses a high degree of risk to not just inmates but also correctional staff.

Description of Project- The scanner's 34" x 72" frame allows it to be placed inside our 1966 small linear jail with minimal structural changes. The scanner is not permanently anchored to the floor, CDC approved, no "safety zone" needed around unit and low-dose x-rays allows subjects to be screened up to 1,000 times per year.

Currently, the Oceana Co. Jail staff strip searches every arrest coming into the jail. Michigan Compiled Laws (764.25a) states a person arrested or detained for a misdemeanor offense-shall not be strip searched unless both of the following occur: the person arrested being lodged into a detention facility by order of a court or there is reasonable cause to believed that the person is concealing a weapon, a controlled substance, or evidence of a crime. (2) The strip search is conducted by a person who has obtained prior written authorization from the chief law enforcement officer. If a strip search is conducted under this section; the arresting officer shall prepare a report of the strip search. The report shall include the following information: name and sex of offender, name and sex of officer, time and date, justification, list of all items recovered, copy of the written authorization and a copy provided to the offender.


The above procedures(s) are not practical for a jail facility or its staff as incoming arrests can be for traffic offenses that do not directly give reasonable cause to believe drug/weapon possession is afoot; other arrestees may not be familiar to staff so we do not know their drug history or intentions. Statistics indicate 70% of subjects coming to jail are addicted to prescription or illicit drugs. Obviously, at this point everyone knows the current crisis of fentanyl in our community.

Furthermore, the current national judicial trends have caused a repeated cycle of inmates coming in and out of our jail. Bonds are now lowered nationally to allow inmates to get out of jail quicker to fight their cases, but their addiction remains. Now, these inmates are bonding out of jail and then "catching" a second case before they have been even sentenced on the first case. This greatly increases the opportunity to bring contraband into the jail. Additionally, courts are using a "delayed sentence" approach. This means the offender gets sentenced, but the judge doesn't remand them immediately to jail. Instead, they are given time to get their affairs in order and then come to jail. This allows them to prepare for jail by ingesting or inserting plastic bags of drugs into their bodies so it can be consumed or shared after coming to jail. Also, there has been an increased female inmate population as well as inmates transitioning from their biological gender coming to jail. This is an unprecedented time for housing people in a county jail.

Over the last 18 months we have had (4) inmates smuggle deadly narcotics in the Oceana County Jail. The one plastic bag of was pure fentanyl. All, but one person required medical

services. The most recent inmate was March 11^{th} , 2024. It was discovered after the inmate attempted suicide in the jail's intake shower.





Funding- We believe this machine will reduce drug over-doses and help protect the health and safety of all of those in jail as well as reduce our risk of liability. The cost is \$142,500 which includes a One Year Parts and Labor warranty. Additional warranties are available.

The Sheriff's Office plans to apply for a grant through Michigan Municipal Risk Management Authority that would reimburse the County up to \$50,000 for installing the scanner at the jail. This grant will be submitted before April 10th, 2024.

The remaining balance of **\$92,500** will come from the Jail Commissary Fund that has received more revenue than expected. The Jail Commissary Fund can be utilized because the scanner will also be able to be used to inspect commissary packages and inmate mail. Note that this is a single quote (Sole Sourcing) as they are the only company that sells this brand specific to correctional facilities.

<u>Can funds from the Opioid Funding be used?</u> At the present time, only Kalamazoo County and St. Clair County have used their settlement money to purchase the Tek84 scanner. I personally feel using this allocated money the county received from the Opioid Settlement would be better spent on new countywide opioid programming.

Allegan, Berrien, Branch, Calhoun, Chippewa, Clinton, Ingham (2), Macomb (2), Manistee, Monroe (2), Ottawa, Saginaw, Van Buren and Wayne (2) have recently purchased this scanner.



Goal- The scanner is not meant to be used to add charges for a person who made a mistake and was found with a personal use amount, but goal is to keep inmates from over-dosing and dying in the jail. Gone are the days when inmates would smuggle cigarettes or marijuana into the jail. Now staff is faced with inmates whose opioid addiction is so outlandish they will insert a deadly drug into their body cavities. No matter how hard the Corrections Deputies try to keep these drugs and weapons out of the jail, they find themselves at a loss due to the listed challenges.

TRANSFER STATION SCALE QUOTES

We recently received updated quotes for the scales for the Transfer Station. Copies of those quotes have been included. GR Metrology provided a quote for a 50' X 11" totaling \$98,729.44. West Michigan Scales provided two quotes. The first was for a 70' X 11' totaling \$73,215 with an option of adding guard rails for \$6,510. The second quote was for a 50' X 11' totaling \$62,305 with an option of adding guard rails for \$4,650. Please let me know when you would like to discuss.

HEALTH DEPARTMENT QUIT CLAIM/LEASE AGREEMENT

The Quit Claim Deed and the release from the Lease Agreement relating to the Health Department have been processed with the County Register of Deeds after review from Commissioner Erickson. The Health Department building is now Oceana County property.

MATERIALS MANAGEMENT

The Materials Management group met on Friday, March 14th to discuss next steps relating to the Materials Management Plans for each of our counties as well as discussion relating to who the DPA would be after EGLE had determined that the DPA must be a governmental agency. We then met with Erin Kuhn of WMSRDC to relay several questions and ask if these items be placed in the agreement that would be signed by the counties. The following is the list of items that were discussed:

- 1. WMSRDC will take the lead in gathering information and reaching out to haulers, recyclers, etc.
- 2. WMSRDC will provide letters for counties to send to adjacent counties and document efforts to collaborate.
- 3. WMSRDC will provide an intergovernmental agreement for execution by the counties and a resolution template that approves the agreement and establishes each county's NOI.
- 4. WMSRDC will be responsible for all public meeting and hearing postings and notices to local units of governments for the DPA and MMPC
- 5. WMSRDC will take the lead in ensuring that the local units are notified of the approval of the plan and their opportunity for approval.

6. WMSRDC as DPA recognizes their ongoing responsibilities to maintain and amend the plan as needed.

WMSRDC will be following up with an updated agreement. The agreement will be provided to each of the boards for approval once it is complete. We are still waiting for some finalization of items through EGLE, which is slowing the process.

REQUEST FOR LETTER OF OPPOSITION

The Michigan Association of Counties sent information stating that a group of senators introduced a Congressional Review Act resolution of disapproval relating to the Interim Final Rule pertaining to ARPA funds. Currently, the final rule states that ARPA funds must be obligated by December 31, 2024, with the expenditure deadline through December 31, 2026. The disapproval resolution if passed would limit the counties' ability to use funds for payroll for compliance and reporting personnel and ability to (re)obligate funds in the case that a contract is unable to fulfill their obligation. It would require the obligation of funds by December 31, 2024. Without the flexibility counties would have difficulty coming into compliance with the ARPA statute. MAC is asking that counties submit a letter of opposition to allow the Interim Final Rule to remain as is. (Please see attached)

OTHER ADMINISTRATIVE ITEMS

As stated previously, we are gathering information for the County Auditors to allow them to complete the County Audit. They are scheduled to be in house May 6 – 10.

Jessica and have been working through changes to the Personnel Manual as presented by the County Attorney. We are hoping to have this completed soon to allow for review by the County Board.



When a vehicle drives onto the scale, there will be longitudinal deflection and the heavier the vehicle is, the greater the deflection will be.







On behalf of the [Number] residents of [Name] County, we urge you to oppose the Congressional Review Act (CRA) joint resolution of disapproval of the Obligation Interim Final Rule (IFR) published by the U.S. Department of Treasury (Treasury) in November 2023. The Obligation IFR provides states and local governments with critical guidance related to the statutory December 31, 2024, deadline for recipients to obligate American Rescue Plan Act (ARPA) State and Local Fiscal Recovery Funds (SLFRF).

The \$350 billion SLFRF provided \$65.1 billion in direct aid to every county, parish and borough in America and since 2021, counties have been using these critical funds to meet the unique needs of our residents and support long-term economic growth. In [Name] County, Recovery Funds have been used to [describe expenditures for responding to the COVID-19 pandemic using ARPA recovery funds such as public health, workforce development and job training, water, sewer, broadband, transportation, Title I and natural disasters].

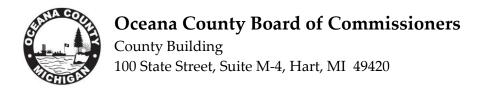
[Name] County and other SLFRF recipients are required by law to obligate all SLFRF dollars by December 31, 2024. Treasury's November 2023 Obligation IFR provides SLFRF recipients to use these funds for payroll costs associated with compliance and reporting personnel through the December 31, 2026, expenditure deadline. Additionally, the IFR provides counties with the parameters in which we can terminate contracts and re-obligate funds beyond the obligation date, which is a crucial flexibility as workforce shortages and supply chain delays persist. Lastly, the Obligation IFR provides subrecipients with the flexibility to re-obligate funds through the expenditure deadline, which is critical to continue the administration of ARPA funded programs through the expenditure deadline.

In short, overturning Treasury's Obligation IFR would limit our ability to use funds for payroll for compliance and reporting personnel and our ability to re-obligate funds in the case a contract is unable to fulfil their obligation. Additionally, it would require that subrecipients obligate funds by December 31, 2024, instead of throughout the expenditure deadline as allowed by the IFR. Without the flexibilities provided through the Obligation IFR, [Name] County and many others across the country may have difficulty coming into compliance with ARPA statute and regulations laid out in Treasury's Final Rule.

Thank you for your continued service to [Name] County. We thank you for your partnership and respectfully ask that you oppose the CRA joint disapproval resolution that would overturn Treasury's Obligation IFR.
