  straightening it out.

- Stony Lake Mr. Mikkelsen stated that the Porter sign has been put up. He would also like to start the process of making the park ADA accessible. The commission members agreed, and Mr. Mikkelsen will work on getting some quotes to bring back to the next board meeting for discussion.

#### **Old Business**

- The County Commissioners approved the Parks Rules and Regulations with one modification. After consulting with Prosecuting Attorney Joe Bizon, Mr. Walker proposed the following change, which Mr. Bizon recommended: "Any violation of these regulations shall, upon conviction, be a civil infraction." This infraction will be enforceable by the Sheriff's Office, and individuals convicted will be subject to a \$100.00 fine.
- Recreation Five-Year plan draft will start the 30-day public viewing period May 2<sup>nd</sup>, 2024, to June 5<sup>th</sup>, 2024. The Recreation plan can be viewed during this time in the Oceana County Clerk's Office. The Oceana Parks and Recreation Commission will hold a public hearing during its regular meeting at 3:00 PM on June 6<sup>th</sup>, 2024. At this time comments regarding the content of the proposed plan will be discussed. The meeting will be held in the Board of Commissions room located at 100 S. State St. Hart, MI 49420.

  - O Crystal Creek Dam Mr. Tiffany is done with the boring and are currently waiting for the results back. At this time, we do not know what the extent of the work that needs to be done.

- ☐ Ms. Byard, the County Administrator, informed Mr. McKeen that the boardroom will be unavailable for the meeting on August 1<sup>st</sup>, 2024. Mr. McKeen suggested two options: either cancel the August meeting or reschedule it to August 9<sup>th</sup>, 2024. He advised the members to consider these options, with a final decision to be made on June 6<sup>th</sup>, 2024.
- Mr. McKeen announced Mr. Warner's retirement scheduled for the end of 2024. He expressed his
  gratitude for Mr. Warner's dedication and contributions to the Parks and Recreation Commission over
  the years.
